- Call to Order & Introductions 6:10pm meeting called to order by Jaime Rabb
- **2. Public Comment on non-agenda items** (2 minutes per speaker) Saunders shared about the utility boxes. He went to a community meeting where the metro rep was there and he asked if they're getting taken out. Metro Rep. says the electrical boxes on Vermont will be staying.
- 3. Approval of Minutes from BOP Committee April 2022 meeting Keaton motioned to approve, Zurita seconded. No objections, April meeting minutes approved.
- 4. Neighborhood Council Elections/Awareness & Engagement Survey presentation by Daniel Johnson from Dept. of Neighborhood Empowerment (DONE) -Discussion/Report/possible action to bring to full board Daniel Johnson, NE, introduced the elections and a google form we can fill out. This process will take about 90 minutes because it will take a while to answer the questions. Johnson shared the links to the google drive with us. There is an Awareness & Engagement Analysis Tool. We looked at the survey results from 2021. Survey closed in January 2022. It is in the NC elections tool dashboard. Data was examined around the voting. There will be a workshop on July 16th about election outreach. We then clicked through the data in order to get to the questions. We filled out an NC Elections Outreach Survey. DONE provides free access to CANVA.
- 5. Second Annual Summer Saturday Extravaganza in Vermont Square Park with CD9 Discussion/Report/possible action to bring to full board CD9 is waiting to see the budget, but is committing to helping at least as much as they did last year. Last year we did 4 Saturdays in a row. It is recommended that we hold these every other Saturday so that it covers an 8 week time span. New budget comes out in July. Our VNC board needs to approve the new budget. We'll need 30 days for the event request and the money to come through, so will need to vote on that to submit event requests.
